CSCPF FINANCIALS



- In 2022, we received approximately \$17,000 in membership fees, certification fees, event fees and donations. This caused a 15% decrease in overall revenue for the year.
- Operations costs, including web-based and telecommunications services, remained relatively unchanged from last year.
- Other Types of Expenses include: Insurance, banking service fees, and the President's stipend, which was increased from \$750 to \$1,000 per month in Q3 2022.
- We ended the year with Net Assets totaling \$425. This is a decrease of almost \$6,000 from 2021. We remain solvent at this time.
